

Dear Rabbit Representative applicant:

We invite you to apply to become the Rabbit Representative. You must complete the application and turn it into the Extension office by Friday, September 6, 2019. All applications will be reviewed and the strongest 6 will be chosen and notified of their interview date. A panel of judges will interview those 6 for the title.

Judging of the applicants will focus on their rabbit project work, experience in the rabbit industry outside of their project work, rabbit industry knowledge, personality, responsiveness to questions and personal appearance. The judges will be looking for the applicant that they feel can best represent the Fairfield County Junior Fair Rabbit show.

Eligible applicants must be 15-18 years old as of January 1, 2019, male or female, and a current 4-H or FFA member in Fairfield County. They must be enrolled in the rabbit project (breeding and/or market), never been married, nor have borne a child. Responsibilities of the Representative will include presenting awards at the Junior Fair shows, speaking during the Rabbit shows and Panorama at the fair, and appearances /participation in 4-H or FFA activities as appropriate.

The application for the Rabbit Representative is attached. Additional applications are available at the OSU Extension Office, 831 College Avenue, Suite D, Lancaster. Applications should be completed with a photo attached and returned to the Extension office by Friday, September 6, 2019.
