Eligible applicants must be 15-18 years old as of January 1, 2020, male or female, and a current 4-H or FFA member in Fairfield County. They must be enrolled in the rabbit project (breeding and/or market), never been married, nor have borne a child. Responsibilities of the Representative will include presenting awards at the Junior Fair shows, speaking during the Rabbit shows and Panorama at the fair, and appearances /participation in 4-H or FFA activities as appropriate.
